

Appointment/Cancellation Policy

To ensure that you get an appointment for the date and time you desire, we suggest booking all appointments a few weeks in advance. Our website displays the most up-to-date availability. Please note that we require a credit card to reserve your appointment with a \$40 deposit fee. As a courtesy to our providers, for non-group appointments, this deposit is nonrefundable in the event you cancel your appointment within the forty-eight (48) hour window. The \$40 deposit will be applied towards any services provided at The Garden of Drip, LLC. If your service is estimated to be less than \$40 then The Garden of Drip, LLC will either refund the difference to your credit card or apply a credit to your account based on the client(s)preference. If the client is looking to reschedule the \$40 will be applied as a credit to your account.

For group appointments that consist of more than three clients, there is a seventy-two (72) hour cancellation policy, and the credit card on file will be charged \$200 if canceled less than seventy-two (72) hours in advance. If you arrive more than fifteen (15) minutes late for your appointment, you may be required to reschedule to avoid disrupting other clients' appointments.

Consultation Policy

We provide free consultations with one of our expert providers. We believe an informed client with realistic expectations will be most satisfied with our treatments and results. Our consultations include a comprehensive discussion about all options available to you, both immediate and long term, and a clear plan of action based on your individual goals. There is a limit of two (2) free consultations per person per 365 days.
